

## ACCESSES



- ✓ Se implantarán medidas para el control del **distanciamiento social de 1,5m** mediante filas específicas de entrada y salida y señalización.

- ✓ Se potenciará la **digitalización de los accesos** y de la atención al expositor y visitante y se controlará los accesos para cada uno de los espacios expositivos



- ✓ El **uso de mascarillas** durante su presencia en el evento será obligatorio.

- ✓ Se colocarán **mamparas protectoras** en los puntos de atención, o se dotarán a las personas de atención al cliente de EPI adecuado (mascarilla y mascara).





## 2. EXHIBITION AREAS

### WHEN VISITING THE EXHIBITION



- ✓ We recommend specific customer helpdesks fitted with screens, signs, hand sanitizer dispensers, etc.
- ✓ Digitalisation of information on stands, at meetings etc. will be encouraged.
- ✓ Aisles will be designed to reduce the density of visitors and ensure social distancing.
- ✓ The layout of furniture on the stand and in communal areas will guarantee social distancing.
- ✓ Communal areas, meeting zones, restaurant areas etc. will be efficiently distributed.

### CAPACITY

- ✓ Signs will indicate the maximum capacity allowed in each space.
- ✓ Control of capacity in each of the exhibition areas.
- ✓ Capacities will be compliant with current regulations.



### HYGIENE MEASURES

- ✓ The necessary hygiene and disinfection measures will be put in place to ensure the safety of installations, including disinfection of large spaces.
- ✓ Maintenance cleaning and readiness cleaning of areas before, during and after events, especially contact surfaces and areas of frequent use.
- ✓ Installations will be constantly ventilated to allow air to be correctly renewed.



Control of permitted capacity and distancing measures in each room where activities such as conferences, talks, sessions, meetings or other types of activities take place.
